ASSOCIATION UPDATE

Greetings on behalf of the Board of Directors,

Well, 2023 is in the books and as usual it was a very interesting year. Depending upon which cloud you were under it was either a good year, a poor year or just another year. We had a good year with Alberta Seed Processors. We feel we accomplished a lot and were busy on several fronts. Our association needs to be proud of the fact that we cleaned just over 40 million bushels of grain. Of this we cleaned about 34 million bushels of seed. Alberta seeds approximately 25 million acres. Of this 6.4 million is canola. Our member plants are providing clean seed to the majority of acres in Alberta. This is a huge value add for Agriculture and all farmers.

FARMER CO-OPERATIVE INVESTMENT

Many of our member co-op's have been in operation for six to seven decades or more. Over this period of time, operational revenue has been reinvested into member facilities in the form of routine maintenance, upgrading to increase handling capacity or to adopt new technology. In some cases major upgrades have nearly doubled capacity within the same building foot print. Strategic investments in new technology and equipment to increase efficiency and drive future growth have been made by several of our members. Most notably are new builds by Camrose County and by the Starland Co-op..

> Alberta Seed Processors Association is comprised of 67 farmer-owned seed & grain processing co-ops. Each co-op is individually controlled by a board of directors, making decisions to best fit their unique local situation.

ASSOCIATION UPDATE

BOARD COMPOSITION & ACTIVITIES

At last year's annual general meeting, Louis Dechaine was re-elected as director in region 5, Uwe Quedenbaum was re-elected in region 6, and Mike Head was re-elected as director in region 7. Dan Brachmann continued his second year as "Board Advisor" This position is a 2-year board appointment, made on an as-need basis. This past year, the new seed plant licensing was the focus project for the Director at Large position. The Managers' Association has appointed Hugh Baier (Provost) and Greg Andrews (Three Hills) as representatives to the Provincial Board. Kellie Jackson, Strategic Evaluation Specialist of the Crop Assurance Programming Section of Alberta Agriculture & Irrigation, sits on the provincial board as our conduit to the Government of Alberta.

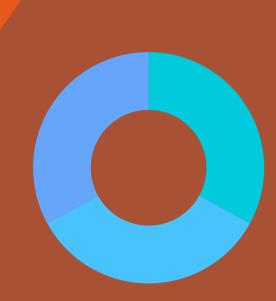

STRATEGIC PLAN

The board has had an active year dealing with key industry changes, such as general reduced government investment in Agriculture which adversely affects the cropping industry value chain. To address the opportunities and challenges in the marketplace, the board has focused on delivering membership benefits that are congruent with the Association's strategic plan.

The Strategic Plan is segmented into the following three areas:

1. Best Practises & Training

2. Group Services & Benefits

3. Market Development & Industry Advocacy

BEST PRACTISES & TRAINING

Continuous learning is the key to building our Association's leadership in the industry. The Manager's Association held a very successful training session this past June in Camrose, with many of the Association's operators and staff in attendance. Many thanks and accolades go to the planning group of Regional Manager's representatives who hosted the very successful training session. Four pesticide applicator credits were available during the manager's training event. Plants that do not apply pesticides also benefited from the sessions, as most of the topics are more general and can help build knowledge

Resources for boards and managers have been uploaded to our 'members only' site. Significant effort has been put into posting resources to enable boards to function at the highest possible capacity. Please check out the 'members only' site under the BOARD RESOURCE TAB. Information regarding HUMAN RESOURCES has also been posted, offering resources from sample employee policies, timesheets, Canada Labor Code, interview questions... the list goes on.

GROUP SERVICES & BENEFITS

COMMERCIAL INSURANCE

NFP Brokers (formerly Foster Park Brokers) indicated that the global insurance business remains in a "hard" market, meaning that some insurance companies have been hit with record payouts due to environmental catastrophes. This means some underwriters are reducing the amount of coverage available, as well as critically analyzing risk. An example of this is Lloyds of London, who have been a long-time underwriter of part of our plan, has chosen not to participate in our program. This leaves a less competitive marketplace in the overall insurance business regardless of the type of insurance. Because of the movement of underwriters, there was a short delay in issuing insurance documents this year. Unfortunately, increases have been incurred for most sites insured either due to increase in coverage or increase in rates. An unwanted, but necessary amendment to the plan is the increase in deductible. However, we are assured that similar coverage outside of our group insurance plan would be close to double the premium. The board recommends that each board read & understand their coverage and the details of deductibles, as the details of coverage have changed as the underwriters for the program have changed.

RISK MANAGEMENT

Wynward Insurance continues its inspections of sites, visiting each site in a random 3-year interval. It is good to have a 'second set of eyes' assessing the plants for possible risks: this all helps keep insurance costs manageable. Even though everyone is busy, and another inspection does cause a bit of disruption, this secondary inspection by a risk management specialist is for individual and collective benefit. Tyson Klassen & his team at NFP are ready to assist anyone with questions or clarifications.

EMPLOYEE BENEFIT PROGRAM

Another year has smoothly passed without major changes to the employee benefits program. The program is provided by Alberta Blue Cross through NFP Brokers. A market scan of the program was conducted this past renewal year. With scrutiny on plan value, as well as the resource that is required to change program providers, should a major savings or coverage differential be offered by a different provider. Upon close inspection as well as receiving input from plan participants, a decision was made to once again renew with Alberta Blue Cross, as other plan providers did not offer significant savings.

PENSION PLAN

The Co-operative Superannuation Society (CSS) Pension Plan provides competitive, value-added retirement products and services exclusively to co-operative and credit union employees. This non-profit pension society ensures that members have a voice in everything we do. The plan's purpose is to serve members and act in their best interest. This is done by providing friendly, personal, transparent and nonconflicted advice within a commission-free environment. The Association does not hold a "group" membership in the CSS Pension Plan; hence each plant needs to enroll as a standalone co-op. Plants are encouraged to check with financial institutions regarding pension/RRSP plans that can also be accessed through local outlets.

MARKET DEVELOPMENT & INDUSTRY CONNECTIONS

FUSARIUM:

After long-awaited regulatory reform removing Fusarium graminearum from the Alberta Pest Control Regulation in 2020, the Alberta crop industry can now focus on best management practices. However, please note that testing seed, whether you are in or outside known fusarium infection areas, is imperative to aid farmers in making critical decisions about their seed quality, regardless of fusarium regulation. To this end, Alberta Seed Processors received Canadian Agriculture Partnership funding to conduct a 3-year fusarium seed infection surveillance project from 2020-2023. Our association compiled data collected by seed labs and works with Alberta Agriculture & Irrigation to create an aggregated map showing critical geographies of forecasted fusarium infection. Many thanks to Dr. Michael Harding for his collaboration. Plans are underway to continue the program which is self-funded from the association's research budget allotment.

SCHOLARSHIP:

The Alberta Seed Processors (ASP) are proud to announce Grayce Flemming and Grace Gregory as the recipients of the 2023 Seed Smart Scholarship. Established in 2017, the scholarship recognizes the academic and personal accomplishments of outstanding young leaders in Alberta's agricultural sector. Recipients are selected on the basis of demonstrated commitment to public service within their communities, academic achievement and future. plans in the agriculture value chain.

REGIONAL VARIETY TRIALS & RESEARCH FUNDING

Provincial funding support for regional variety trials (RVT) ended in December 2020. Your Provincial Association collaborated with Alberta Seed Growers, Key Industry Stakeholders and Alberta Wheat & Barley Commissions to ensure the cereal RVT program has a sustainable future. As part of industry collaboration, Alberta Seed Processors is pleased to act as the gatekeeper of a sustainable Silage RVT program operating a 2-year funding project that started in January of 2023. Under the expert guidance of Dr. Sheri Strydhorst, the project operated trials at 6 sites this past season. Drought and human error rendered a few trails unusable. Results have been published in the 2024 Spring ALBERTA SEED GUIDE.

A revitalization of the website to improve the seed & seed processing search feature was completed early in 2022, with updates being made in 2023 using our updated membership information. 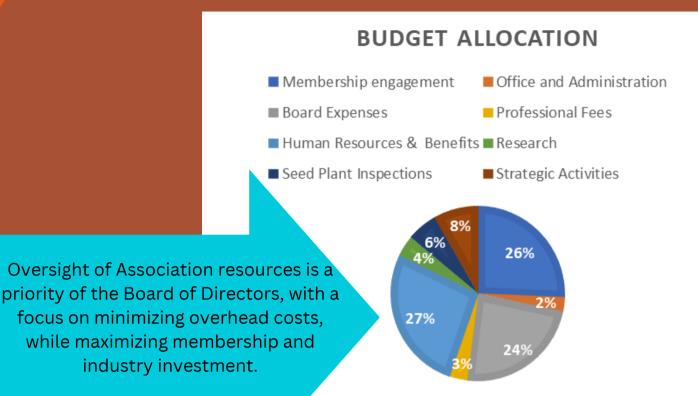

ASSOCIATION MANAGEMENT



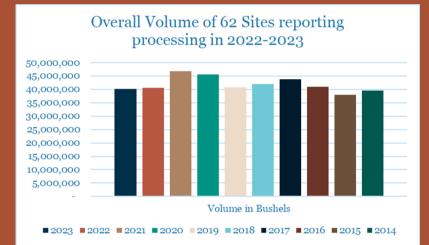

Historical Volume Range

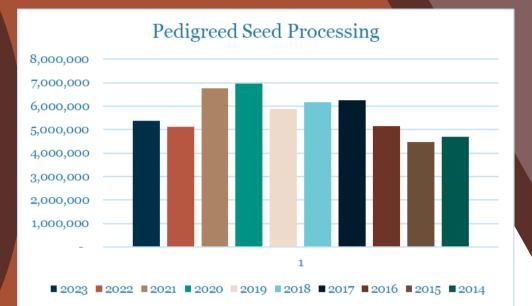

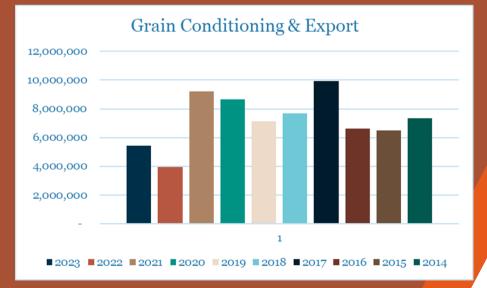

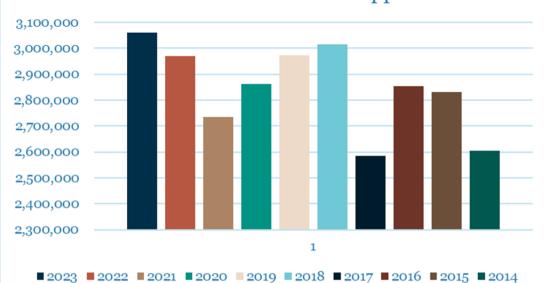


GRAIN CONDITIONING



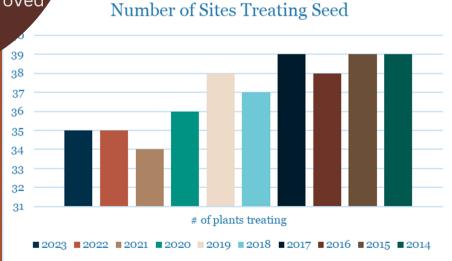
